International Conference hosted by the Federal Ministry of Labour, Social Affairs, Health, Care and Consumer Protection of the Republic of Austria, focussing on integration of Roma/Romnja and Sinti/Sintizze into the labour market of the Danube Region.

There are several occasions and anniversaries for this conference:

- 20 years: "European Parliament Resolution on the Situation of the Roma in the EU" and "Thara Projects of Volkshilfe Austria"
- 15 years: "European Union Roma Strategic Framework for Equality, Inclusion and Participation" and Inclusion of Vulnerable Groups within the "Danube Region Strategy"
- 10 years: "Roma Empowerment for the Labour Market" Programmes and Projects in Austria, co-financed also by the European Social Fund (ESF)

20 years ago, in April 2005, for the first time, the European Parliament has condemned all the forms of discrimination faced by the Roma people and urged all Member States and candidate countries to take concrete measures to improve the access of Roma to labour markets with the aim of securing better long-term employment. In Austria, in the same year, within the framework of the EQUAL Programme, the association Volkshilfe Österreich started a series of labour market projects for the Roma community called "Thara".

Consequently, in 2010, the efforts for Roma integration became more formalised within the EU Roma Strategic Framework for Equality, Inclusion and Participation, establishing National Roma Integration Strategies in the Member States, including respective programmes and policies. A specific geographic focus was added in the same year under the umbrella of the EU Strategy for the Danube Region, which also puts an emphasis on the integration of vulnerable groups in countries with significant Roma populations.

In Austria, from 2015 onwards, "Roma Empowerment for the Labour Market" Programmes and Projects support the integration of Roma and Sinti into the labour market. These projects were co-financed by the European Social Fund (ESF) and, since 2022, are funded by national resources through a Special Directive that is valid until 2030.

Despite the progress in some respects, challenges faced by Roma people remain tremendous in many Member States and candidate countries, which makes mutual learning a necessity. Speakers and project promoters from the Danube Region will have the opportunity to highlight and discuss challenges and best practices with the aim to find answers for the future.
