The conference is hosted by the Federal Ministry of Labour and Economy and the Federal Ministry of Education, Science and Research of the Republic of Austria in the framework of the 2024 Austrian Presidency of the EU Strategy for the Danube Region.

Advancing Fair, Green, and Digital Transition in the Danube Region: Prioritizing People and Skills

The labour market and education systems in the Danube Region are undergoing profound transformations, shaped by four key factors on which the conference is going to focus:

- The **Green Transition** is fundamentally reshaping both education systems and the labour market. Developing green skills is essential for filling Green Jobs, which are pivotal for fostering a climate-neutral and sustainable Danube Region.
- **Digital technologies**, particularly artificial intelligence, are revolutionizing how we work and learn. Adapting to ongoing digitalisation demands acquiring new skills to navigate its challenges and seize its opportunities effectively.
- In this dynamic landscape, ensuring **inclusivity** is paramount. Given the significant economic and social disparities in the Danube Region, the success of its digital and green transitions hinges on their **fairness**. Priority should be given to integrating vulnerable groups in the Danube Region.
- Moreover, it is imperative to involve the voices of the **youth** in shaping the future of a fair, green, and digital Danube Region.

Within the framework of the European Union Strategy for the Danube Region (EUSDR), Priority Area 9 "People and Skills" serves as a pivotal platform focusing on labour market dynamics and education policies. This emphasis provides a suitable foundation for addressing the aforementioned challenges and formulating initiatives, projects, and policies accordingly. Furthermore, it effectively contextualizes pan-European strategies and initiatives such as the European Green Deal, the European Pillar of Social Rights, and the European Skills Agenda within a regional framework. The EUSDR plays a crucial role in creating a level playing field for both European Union Member States and candidate countries, thereby fostering a more inclusive and cohesive Europe. Given the geopolitical tensions at the edges of the Danube Region, notably Russia's illegal invasion of Ukraine, concerted efforts in labour and education policies are imperative. Notably, Priority Area 9 "People and Skills" is jointly coordinated by Austria, Ukraine, and the Republic of Moldova, underscoring its innovative nature as a platform for cooperation with emerging candidate countries.
