## **Young People in Times of Crisis:**

# **Building Responsive Education, Training and Labour Market Systems in the Danube Region**

**Date:** Thursday, 9 June 2022, 9.00-16.30 CET

**Format:** International conference in a hybrid format on challenges and future priorities with respect to effective education, training and labour market policies and related projects to support young people in the Danube Region in the context of the war in Ukraine, the COVID-19 pandemic and climate change. The conference will be held in English and no interpretation will be provided. Participants may attend in person in Vienna or follow the conference online. The conference is hosted by the Federal Ministry of Labour and the Federal Ministry of Education, Science and Research of the Republic of Austria.

The European Union has designated 2022 as the European Year of Youth (EYY), highlighting the role of young people for the future of Europe. Supporting young people in acquiring relevant knowledge and competences, as well as promoting opportunities for their personal, social, economic and professional development are among the objectives of the EYY.<sup>1</sup>

The war in Ukraine has disrupted the lives of young people in Ukraine and has forced many to leave the country. This has particularly affected areas in the Danube Region, both in Ukraine itself and in other Danube Region countries. Providing psychosocial support to young Ukrainians and integrating Ukrainian refugees into education and labour market systems in these extremely challenging times is essential.

The compounding impact of the COVID-19 crisis on educational outcomes, mental health, early school leaving and employment opportunities demands specific focus to young people during the process of recovery. Support is needed to ensure that no one is left behind, including young people not in education, employment, or training and those from vulnerable groups.

Priority Area 9 (PA9) “People and Skills” of the EU Strategy for the Danube Region (EUSDR) covers key areas that affect the lives of young people: education, training, labour market and inclusion. Actions agreed on within the framework of PA9 are essential for post-COVID-19 recovery and beyond: In the area of education and training, these include ensuring high-quality education, promoting relevant skills, strengthening vocational education and training, and reducing early school leaving. The labour market actions of PA9 include cooperation, innovation and digitalisation of the labour market in the Danube Region, as well as the integration of vulnerable groups, the fight against poverty and inclusion for all.

Education is also essential for the empowerment of young people. It teaches the civic competences needed to participate in democratic life, to address discrimination and to contribute to an inclusive society. Moreover, it is essential to provide young people with employment opportunities and the transition from school to work has a crucial role to play in this endeavour. Participation of young people in the governance structures of the EUSDR has been a key priority under the Slovak and Ukrainian presidency. In addition to this, attention must be paid to bottom-up initiatives and the overall socio-economic situation of young people in the Danube Region.

Young people play a key role in supporting the digital and green transition. The United Nations 2030 Agenda for Sustainable Development acknowledges the role of young people as critical agents of change<sup>2</sup>. Promoting young people's digital and green skills equips them for jobs in the 21<sup>st</sup> century and drives innovation and creativity, which are imperative in finding solutions for addressing complex challenges, such as climate change.

The 10<sup>th</sup> International Stakeholder Conference of PA9 takes stock of existing initiatives and developments on EU and macro-regional levels and discusses how empowering young people through education and training, as well as labour market policies in times of crisis can contribute to a more responsive Danube Region.
