The conference is hosted by the Ministry of Education and Science of Ukraine and Ukrainian Institute for International Politics in partnership with the Federal Ministry of Labour, Social Affairs, Health, Care and Consumer Protection and Federal Ministry of Education of the Republic of Austria, the Ministry of Education and Research and the Ministry of Labour and Social Protection of the Republic of Moldova, OeAD – Austria's Agency for Education and Internationalisation and L&R Social Research.

**Background.** The general objective of the conference is to be an open, transparent and inclusive platform to stimulate the emergence of new ideas and best practice exchange among the diverse list of Danube Region stakeholders. Therefore, participants are invited to bring along questions, ideas, and initiatives.

Since the previous stakeholder conference in June 2024, the European Commission has further strengthened its focus on creating a fair and inclusive social market economy by signing the Pact for European Social Dialogue and introducing the Union of Skills. It is high time to start embedding key principles of more social Europe – in the light of middle- and long-term consequences of the war in Ukraine as well as the EU accession process of Ukraine, the Republic of Moldova and the Balkan states. Education, social and labour systems have been under significant pressure for several past years and thus require innovative approaches and increased resilience to be able to resolve current issues and face the approaching challenges.
