overview of the 36 EUSDR shortlisted strategic topics, aligned to the priorities of the ERDF/CF MAs based on the indicated POs/SOs.
















c. Monitoring & Evaluation

EUSDR Monitoring Tool

- beta-version shared with PACs in July 2021
- to be implemented as an online tool from 2022 (reporting once in 2 years)
- one comprehensive monitoring (EC, DTP & additional questions)
- no double reporting
- strategic decision making support tool for NCs












