
... we cross-link

... we support


developments and strategies in education with our information tools, transparency tools and our expertise (60 conference contributions, 30 OeAD experts in committees, 80 contributions in media)

The Structure



National Agency Erasmus+ Education

Erasmus+ is the EU's programme to support education, training, youth and sport in Europe. Its budget of €14.7 billion till 2020 will provide opportunities for over 4 million Europeans to study, train gain experience, and volunteers abroad.

The following programme countries can fully take part in all Erasmus+ programme actions:

- the 28 Member States of the European Union,
- the EFTA/EEA countries: Iceland, Liechtenstein and Norway,
- EU candidate countries: Turkey and the former Yugoslav Republic of Macedonia.

In addition, certain Erasmus+ programme actions are open to organisations from partner countries.

3 main types of Key Action

Learning mobility of individuals (KA1)

- ➔ Staff mobility, in particular for teachers, lecturers, school leaders and youth workers
- ➔ Mobility for higher education students, vocational education and training students
- ➔ Student loan guarantee
- ➔ Joint Master degrees
- ➔ Mobility for higher education for EU and non-EU beneficiaries
- ➔ Volunteering and youth exchanges

Cooperation for innovation and exchange of good practices (KA2)

- ➔ Strategic partnerships between education/training or youth organisations and other relevant actors
- ➔ Large scale partnerships between education and training establishments and business: Knowledge Alliances & Sector Skills alliances
- ➔ IT-Platforms including e-Twinning
- ➔ Cooperation with third countries and focus on neighbourhood countries

Support for policy reform (KA3)

- ➔ Open method of Coordination
- ➔ Prospective initiatives
- ➔ EU recognition tools
- ➔ Dissemination & exploitation
- ➔ Policy dialogue with stakeholders, third countries and international organisations

Erasmus + Education – Aims

- Reducing unemployment, especially among young people
- Promoting adult learning, especially for new skills and skills required by the labour market.
- Encouraging young people to take part in European democracy
- Supporting innovation, cooperation and reform
- Reducing early school leaving
- Promoting cooperation and mobility with the EU's partner countries
